# What's New in Release 2005 SP01

## Enhanced Add-Ons

### Fixed Assets

The Fixed Assets add-on now supports the following additional features and functions:

- In the *Fixed Assets Master Data*, you can use a new tab, *Cost Accounting*, to assign a Project and Distribution Rule (Profit Center).
- When posting a transaction, the system records the Project and Distribution Rule (Profit Center) information into a journal entry.
- With the Depreciation Run feature, you can now summarize the depreciations for a Project and Distribution Rule (Profit Center).
- In the *Depreciation Type* window, the following new features are available:
  - ◆ *PR Temporis Type*  
When the *Period Control* is *Pro Rata Temporis*, you can select a PR Temporis Type.
  - ◆ *Depreciation in Month of Retirement*  
You can choose to run, or not run, depreciation in the asset retirement month based on the *Period Control Retirement* definition.
  - ◆ *Percentage of Depreciation to be Reversed in Retirement Year*  
By setting the *Percentage of Depreciation to be Reversed in Retirement Year* parameter, you can choose to reverse depreciation in the retirement year.
- The system supports the use of non-monthly calendar fiscal years such as a 4-4-5 calendar definition.

### Payment Engine

#### Cash and Bank

The Payment Engine add-on now supports the following additional features and functions:

- The system can automatically reconcile the credit memo with the payment document you have added.
- Payment reference functionality is now available for Belgian localization.
- In addition to a journal entry, the system can also create a payment document for the Incoming and Outgoing Payment to G/L Account transaction.

## Microsoft Outlook Integration

The Microsoft Outlook Integration add-on now supports the following additional features and functions:

- The system automatically remembers the last successful login information, including the DB password, and uses it as a default.
- In the *Quotation* window for sales quotations, a % *Discount* field is now available for line items.

## XL Reporter

The XL Reporter add-on now supports the following additional features and functions:

- The XL Reporter superuser can now grant standard users permission to access all the features of XL Reporter to create and modify reports.
- The reporting and analysis capabilities in SAP Business One have been enhanced through further changes and additions to XL Reporter's Meta Data Repository.
- XL Reporter now offers a list of period functions that users can apply when choosing a period parameter for a report definition selection.
- When specifying a dimension attribute in a cell of a report definition, users can now specify additional attributes within the same cell, in an uncomplicated way.
- When filtering data selections in a report in Report Composer, users can now filter on a date range instead of on just one particular date.
- Enhancements and additions have been made to the *Advanced Report Builder* window. These include an option to filter on a module before specifying selections, as well as more self-explanatory tool tips for some buttons.
- Enhancements and additions have been made to the *Formula Builder* window. These include a new tab in which users can add Microsoft® Excel functions that they often apply as well as a more intuitive overview of the available data items on the *Display* tab.
- Enhancements and additions have been made to the *Parameters* window. These include the more intuitive use and naming of the buttons in the window.
- The refresh functionality (*F5*) in Report Organizer has been improved so that sub-levels selected in the tree structure continue to be displayed when a refresh is performed.
